PURPOSE: The Artist appoints the Exhibitor as a non-exclusive agent for the purpose of displaying and exhibiting the Artist's work(s) of art specified above or in an appendix to this Agreement ("Artwork(s)") as part of the Creativity and Parkinson's Project, a component of the Exhibitor's Living With Parkinson's Initiative. Exhibition of Artwork(s) on www.PDF.org is at the sole discretion of the Exhibitor.

REPRODUCTION, PUBLICATION AND DISPLAY: The Artist grants to the Exhibitor or its subcontractors a non-exclusive license in the United States of America to reproduce, publish and display the Artwork(s) (A) in any media to promote the Creativity and Parkinson's Project, (B) in the website at www.PDF.org, and (C) in photographic slides, DVD projections, posters or other media at conventions, meetings, educational symposiums or other venues which are consistent with the research, education or advocacy mission of the Exhibitor and with the sponsors of which the Exhibitor would have a prior written agreement for use of the Artwork(s).

WARRANTY: The Artist warrants to the Exhibitor and the subcontractors of the Exhibitor that the Artist created the Artwork(s) and possesses unencumbered title to the copyright to the Artwork(s).

INDEMNIFICATION: Artist shall indemnify Exhibitor and its subcontractors against all costs and expenses (including reasonable attorney's fees) incurred by Exhibitor or its subcontractors in connection with any claims made against Exhibitor or its subcontractors that the reproduction, publication or display of the Artwork(s) infringe(s) upon another person's copyright.

INTEGRATION: This Agreement constitutes the entire understanding between the parties. Its terms can be modified only in writing signed by **both** parties. It may be terminated by written notice to either party.
